



Conditions of Entry - Las Vegas Promotion

ENTRY CONDITIONS

This document contains the terms and conditions of entry ("Terms") into the 'Las Vegas Promotion'. Entry into this promotion is deemed acceptance of these Terms. There is a total of One (1) Prize to be won.

The Promoter is Canberra Raiders Pty Ltd, ABN: 31 068 819 152, 14 Torrens Street, Braddon ACT 2612 Australia ("Promoter").

The Prize Supplier is Elite Travel ABN 97 160 269 652, Level 14, 3 Parramatta Square, 153 Macquarie St, Parramatta, NSW - 2150 ("Supplier").

The Promotion will open 10am Friday 15 November 2024 Australian Eastern-Standard Time ("AEST") and will close 11:59pm Sunday 15 December 2024 Australian Eastern Standard Time ("AEST") ("Promotion Period"). All entries must be received by the Promoter/Supplier during the Promotion Period.

The Promoter and the Supplier reserve the right to change the Promotion Period at any time. (e.g. extend the promotion closing date, to deliver the agreed digital value scheduled for the Promoter / Prize Supplier)

The promotion is open to Australian residents,18 years and over, residing in ACT, NSW, Vic, Tas or Qld.



Employees of the Promoter/Supplier and other agencies, firms or companies associated with this Promotion, and their immediate families ("Eligible Entrants") are ineligible to enter.

Immediate family means any of the following: spouse, ex-spouse, defacto spouse, child, or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister, or 1st cousin.

The Promoter/Supplier, subject to State and Territory legislation, reserves the right not to accept a registration for any entrant (or to disqualify an entrant) if the Promoter/Supplier considers that the registration contains anything defamatory or is otherwise inappropriate or is not submitted in accordance with these Terms.

An entrant may only register as an individual with only one valid entry per person membership accepted into this promotion. The winner (1) will be randomly selected from all entrants who have entered all details correctly into the appropriate forms.

The Promoter and the Prize Supplier, reserve the right to change the prize draw date at any time.

The winner of the prize will be notified by telephone and in writing, within Two (2) business days of the draw. The winner also acknowledges and agrees that their name <u>may</u> also be published by Elite Travel website, social media, or email communications from Midday Monday 16 December 2024.





If the winner is unable to be contacted, and all reasonable methods of communication are unsuccessful, the unclaimed prize may be redistributed via an unclaimed redraw conducted by the Promoter/Prize Supplier 10am Wednesday 18 December 2024.

The Promoter/Supplier collects personal information to conduct the promotion and may, for this purpose, disclose such information to third parties, agents, contractors, service providers. Entry is conditional on providing this information.

By participating in this Promotion, the Eligible Entrant agrees and acknowledges that:

- a. They may be contacted by the Promoter/Supplier to provide comments about Canberra Raiders / Elite Travel promotions and offers.

- b) any theft, unauthorised access, or third-party interference.
- c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter/Supplier) due to any reason beyond the reasonable control of the Promoter/Supplier.
